Who is Vitol power Brasil?

The new company is called Vitol Power Brasil and aims at serving large energy consumers. The company received an initial investment of R\$108 million, is backed by its parent company, and has already started its first operations.

Why did Vitol join Brazil's power industry?

Vitol joins Brazil's power industry with a long-term vision and commitment, bringing all its trading expertise from around the world to this market," he said. What's new in Brazil's energy bill?

Brazil's Senate approved a wide-ranging energy bill on Thursday that establishes a regulatory framework for offshore wind energy projects while including unrelated amendments promoting polluting energy sources like coal and natural gas.

How much power does Brazil lose a year?

Brazil, with a large and complex grid system that has not fully kept up with the demands of the energy transition, loses about 16% of the power it generates. Historically, Brazil has lacked investment in new grid infrastructure, particularly in remote areas where the potential for renewable energy development exists.

What does Vitol do for a living?

Vitol's renewable energy business in the United States includes more than 1 GW of solar and wind power in operation or under construction and an additional pipeline of more than 2.5 GW of projects in solar and battery storage, totaling investments of more than \$1 billion.

How is Brazil's power industry expanding?

Brazil's power industry is expanding mainly through the free market. Some trading companies are expanding their operations by offering services to consumers and generation companies and building greenfield projects specifically for renewable sources.

Vitol has agreed to acquire 50% of Brazilian downstream company Rodoil for an undisclosed sum. Rodoil is a

market leader in the southern part of Brazil with a downstream network comprising some 300 branded service stations and a distribution business supplying an additional 1,400 plus service stations through its network of 10 strategically located terminals.

"Brazil is the largest energy market in South America, with more than 70 GW of demand and several large players. Vitol joins Brazil's power industry with a long-term vision and commitment, bringing all its trading expertise from around the world to this market," he said.

Of this amount, Vitol will pay \$90 million directly to DOJ and another \$45 million to the government of Brazil. The Commodities Futures Trading Commission has ordered Vitol to pay \$95 million in disgorgement and civil penalties, some of which will be offset by the criminal penalties, but at least \$28 million will go directly to the CFTC.
