In the 1950s, we decided against developing a tramway for the island and so removed the word "Traction" from the Company's name and became what we all know today as the Bermuda Electric Light Company Limited - BELCO. We embraced new technologies as we grew.

Who owns Bermuda Electric Light Company Limited (Belco)?

Bermuda Electric Light Company Limited (BELCO) is a wholly owned subsidiary of Liberty Group Limited. Liberty Group Limited is a Bermuda-based provider of energy and energy-related services, owned by Algonquin Power & Utilities Corp. (Algonquin). Algonquin is the parent company of Liberty Power and Liberty Utilities, collectively known as Liberty.

When did Belco start supplying electricity in Bermuda?

BELCO was incorporated in 1904 as the Bermuda Electric Light, Power & Traction Company (B.E.L.P.&T.), and started to supply electricity in Bermuda on 1 May 1908. The Company purchased its present site on Serpentine Road, Hamilton in 1909 and moved its operations there.

What is Bermuda's Integrated Resource Plan?

On July 26, 2019, the RA released Bermuda's first Integrated Resource Plan, which outlined the framework for Bermuda's energy requirements over the next 25 years. The IRP aimed to have 85% of Bermuda's power generated by renewable means by 2035.
