Does shell support solar PV projects in the UK?

Shell has signed deals with two of the UK's leading solar PV developers to support the establishment of new utility-scale solar PV projects in the UK.

#### Will a UK government back solar?

Signs of a UK government that's prepared to back solarhave emerged within a fortnight of the Labour Party securing victory in the General Election. The government has already signed off on more than 1 GW of new solar capacity. It's been a whirlwind two weeks for the UK solar industry.

### Does the UK government want the solar industry to grow?

The government has already signed off on more than 1 GW of new solar capacity. It's been a whirlwind two weeks for the UK solar industry. Chris Hewett, chief executive of Solar Energy UK, told pv magazine he believes the new UK government "unambiguously" wants the industry to grow, a first for the trade association.

#### When will EDF renewables UK start generating solar power?

Two consented projects that EDF Renewables UK added to its solar portfolio in March 2021 at Burwell (49.9 MW) in South East Cambridgeshire and Porth Wen (49.9MW) in Anglesey have progressed to the site preparation and construction stage, with the expectation that first generation will be in Q4 2022.

#### When will the European Solar charter be implemented?

One year following the signature of the Charter, the Commission will review the implementation of the adopted commitments. The European Solar Charter, signed on 15 April 2024, sets out a series of voluntary actions to be undertaken to support the EU photovoltaic sector.
