What is a floating solar PV system in Tuvalu?

From solar rooftops and the Off-grid sola-powered Capacitive Deionisation (CDI) systems to the pioneering floating solar PV with 100kW. innovative solutions like floating solar panels (a first for the PICs) and raised solar installations are being embraced in Tuvalu as the Pacific grapples with addressing the challenge of limited land space.

What is the Tuvalu solar power project?

The Government of Tuvalu worked with the e8 group to develop the Tuvalu Solar Power Project, which is a 40 kW grid-connected solar systemthat is intended to provide about 5% of Funafuti 's peak demand, and 3% of the Tuvalu Electricity Corporation's annual household consumption.

What was the first large scale solar system in Tuvalu?

The first large scale system in Tuvalu was a 40 kW solar panel installation on the roof of Tuvalu Sports Ground. This grid-connected 40 kW solar system was established in 2008 by the E8 and Japan Government through Kansai Electric Company (Japan) and contributes 1% of electricity production on Funafuti.

Where does Tuvalu electricity come from?

Tuvalu's power has come from electricity generation facilities that use imported dieselbrought in by ships. The Tuvalu Electricity Corporation (TEC) on the main island of Funafuti operates the large power station (2000 kW).

What's happening with Tuvalu's mini-grids?

As Tuvalu journeys towards scaling upits mini-grids systems, the spotlight shifts to the electrical contractors poised to take on installation, operation, and maintenance tasks. The Federal Investment Tax Credit (ITC) is a 30% tax credit against eligible costs of solar installations and the largest single economic enabler for the residential solar industry as it reduces costs for homeowners. The ITC was originally passed as federal policy in 2005 and has been renewed several times since then.

The one megawatt solar PV plant, which was expanded from 600kW following a grant from the New Zealand Ministry of Foreign Affairs and Trade, bolster energy resilience and reduces costs associated with diesel imports.

own the solar panels, have taxable income, and it must be installed at your primary or secondary residence.

The installation of Tuvalu"s inaugural 100.28kWp Floating Solar Photovoltaic System (FSPV) consists of a total of 184 x 545W Sunergy solar panels with a solar floating mounting system. Through this new FSPV system 174.2MWh of electricity will be generated each year, meeting two percent of Funafuti"s annual energy demand.
