Will Morocco double green electricity production in Western Sahara?

Get in Touch Morocco, buoyed by recent foreign recognition of its rule over Western Sahara, plans to double green electricity production in the disputed territory to meet growing demand before it co-hosts the 2030 FIFA World Cup.

Is Morocco dependent on Western Sahara for its energy supply?

But these developments have made Morocco partly dependenton Western Sahara for its energy supply. Morocco already gets 18% of its installed wind capacity and 15% of its solar from the occupied territory, and by 2030 that could increase to almost half of its wind and up to a third of its solar.

Who is involved in hydrocarbon exploration in Western Sahara?

There are today two companies involved in hydrocarbon exploration in Western Sahara - both are from Israel. The other company is Ratio Petroleum, which secured the Dakhla Atlantique offshore block in October 2021. occupied land to date: another step forward in its comprehensive plan to build controversial infrastructure on the land it illegally holds.

As such, the projects fundamentally undermine the UN peace efforts in Western Sahara directed towards allowing the expression of the right to self-determination of the Saharawi people. The energy is used by industries that plunder the territory's non-renewable resources, and provides job opportunities attracting more settlers from Morocco.
