How many commercial registers are there in Switzerland?

It is updated every day and can be accessed through the Central Business Name Index,Zefix. However,the cantons are responsible for the management of the register and must have at least one register. In the canton of Valais (VS),the register is kept by the district. There are currently 28commercial registers in Switzerland.

Where can I find information about a company in Switzerland?

The information is available on the Zefix portal. Paid entries in the commercial register are also published in the Swiss Official Gazette of Commerce. Essential information on registered companies is also found in the Swiss Directory of the Commercial Register. New entrepreneurs are often contacted by private registers.

Subsidiaries (AG or GmbH) have their legal personality, with liability limited to the entity's capital. Financial and Tax Obligations: Branches do not have separate bookkeeping obligations under Swiss law; this responsibility falls on the main company.

Do employers have to contribute to the Swiss Social Security system?

The employer is indeed required to contribute to the Swiss social security system. Article 18, paragraph 2 of the Switzerland-UK agreement is equivalent to Article 21, paragraph 2 of EU Regulation 987/2009. This equivalence ensures that the same application and obligations apply to UK employments as they do for EU employments under the regulation.
