Units of BYD,Longi,Canadian Solar,Trina Solar and New East Solar were found in violation of trade lawsand now face heavy tariffs. Three major suppliers were found to not be in violation.

Are Chinese solar panels evading US tariffs?

Why are solar panels banned in Xinjiang?

The U.S. government has taken steps to crack down on forced labour in the supply chain for solar panels in Xinjiang, including a ban on imports from a silicon producer there. In contrast,e Canada has banned the import of solar panels from specific Chinese companies due to concerns over human rights violations.

Who are JA Solar & Trina & qcells?

The Ministry of Defence listed JA Solar, Trina and Qcells as the solar panel suppliers in response to a BBC Freedom of Information request. A report in July this year by the UK's Sheffield Hallam University flags the three companies as having " very high" exposure to production in Xinjiang.
