People born in the U.S. Virgin Islands derive their U.S. citizenship from congressional statute.

The U.S. Virgin Islands are organized under the 1954 Revised Organic Act of the Virgin Islands and have since held five constitutional conventions. As with other territories in the United States, the Virgin Islands elects a delegate who can participate in debates in the House of Representatives but cannot vote.
