What is the energy mix in Yemen?

However, Yemen's current energy mix is dominated by fossil fuels (about 99.91%), with renewable energy accounting for only about 0.009%. The national renewable energy and energy efficiency strategy, on the other hand, sets goals, including a 15% increase in renewable energy contribution to the power sector by 2025 (Fig. 11).

What is the main energy source in Yemen?

According to the International Energy Agency,in 2000,oilmade up 98.4% of the total primary energy supply in Yemen with the remainder comprising biofuels and waste (International Energy Agency). Natural gas and coal were introduced into the energy mix around 2008,and wind and solar energies were added around 2015.

How is Yemen dealing with energy problems?

Due to the fighting, certain energy systems have been completely damaged, while others have been partially devastated, resulting in a drop in generation capacity and even fuel delivery challenges from power generation plants.
