How many coal-fired power plants does CEZ Group have in Poland?

CEZ Group has a total installed capacity of 569 MW in Poland. It operates twocoal-fired power plants: CEZ Skawina (330 MW) and CEZ Chorzów (238 MW),which burns biomass in addition to coal. Both also operate as heating plants.

Why is energy production increasing in Poland?

At the same time, energy production from natural gas increased, by more than 40%. This is a result of falling fuel prices and the flexibility of gas generation. Wholesale energy prices in Poland compared to other EU countries remain very high, and the economy's dependence on imported fossil fuels is growing rapidly.
